1. Administration Commission Exemplary Leadership Award

- 2. Administration and Region V Joint Conference—May 17 to 18, 2017, FKCC; This is the 2nd Year Administration Commission has joined Region V at the Regional Conference, and it was a great success.

The Administration Commission has sponsored the following Presentations at the Conference:

a. Presenter Lynne O'Dell, IRSC

IRSC's Quality Enhancement Plan (QEP) is "an action research project Improving Student Learning and Success in Gateway Math." IRSC's QEP has implemented significant changes to the institution's gateway math courses that include a variety of delivery methods, the addition of tutors in the classroom, MARS computer labs, and active learning strategies. The effect of these changes were not immediately evident in the data collected, therefore focus groups are conducted each term. Focus groups for IRSC's QEP have proven to be an important part of our action research project giving insights into what changes are and are not working. Focus groups are conducted every term with students, faculty, and tutors that are involved in the redesign of our institution's gateway math courses. During this session qualitative data from the past 3 years of focus groups will be shared, along with an explanation of the process for conducting focus groups, lessons learned, successes, and failures. Implications for scaling out the use of focus groups to other disciplines will also be shared. A question and answer session will follow the presentation.

b. Presenter: Marcos A. Nunez, Broward College

Title: 2017 Top Trends in Innovative Technologies for Higher Education

This interactive presentation discusses key trends, significant challenges, and developments in educational technology that are poised to impact teaching, learning, and creative inquiry in higher education in the next 5 years. Attendees will have the opportunity to reflect on and experience some of these technologies hands-on through a combination of onsite and web simulations. Some of the most important developments discussed will be: Mobile Learning, Internet of Things, Artificial Intelligence, and Natural User Interfaces. Some of the trends: Learning Analytics, Learning Space Redesign, and Cultures of Innovation.

c. Presenters: Joan Rivera and Brenda Rante, IRSC

How prepared are you for a disaster?

As a coastal community with previous landfall from major hurricanes, IRSC AFC wanted to make sure that faculty are informed and prepared for future storms. Our goal is to keep members and their families safe by engaging them to actively prepare for disasters. A presentation was developed including: two interactive activities, one PowerPoint, multiple handouts, and a Q and A session.
