Policy and Advocacy Committee Meeting

- 1.0 Welcome and Remarks
Dr. Falconetti called the March 18, 2022, Policy and Advocacy Committee Meeting to order at 1:05 p.m.

- 2.0 Legislative Update
Dr. Falconetti shared the General Appropriations Bill is pending Governor DeSantis' signature. She stated that everyone played an important role in ensuring the success of every institution in the Florida College System. She said the Florida College System will benefit from funding related to the American Rescue Plan and COVID-19 funding this year. There is \$400 million allocated for deferred maintenance in the FCS. Dr. Falconetti thanked Mr. Seth McKeel, Ms. Lacey Hofmeyer, Ms. Eired Eddy, Ms. Karen Moore, Ms. Kendra Parsons, Senior Chancellor Mack, and Chancellor Hebda for their support throughout the session.

3.0 Council of Presidents Minutes

Council of Presidents' Zoom Business Meeting Minutes – February 17, 2022

Action: *Upon a motion by Dr. Leitzel and a second by Dr. Sidor, the February 17, 2022, Council of Presidents' Zoom Business Meeting Minutes were unanimously adopted.*

4.0 Report of the Chair – Dr. Angela Garcia M. Falconetti

Dr. Falconetti stated the focus has been on the Legislative session and making sure the agenda for the Council of Presidents was received successfully. She said she was looking forward to representing the Council of Presidents at the State Board of Education meeting later in March.

5.0 Report of the Chancellor, Division of Florida Colleges – Chancellor Kathy Hebda

Chancellor Hebda gave her congratulations on the budget thus far, and the work everyone did to contribute and help to advocate for the Florida College System. She stated Lisa Cook along with the college budget office prepared the usual side-by-side budget document which shows where the budget stands before any action is taken by the Governor. The document was emailed before the COP meeting. She received several questions and wanted to address those during this meeting. There was a question about statewide projects and if the funds were recurring or non-recurring funds. Chancellor Hebda stated they are non-recurring funds, and anything labeled as operational support funding is recurring funds. She said another question was from page three in the document asking if the college by college numbers included funds from the nursing grant. She stated they are not a part of the funds documented on page three.

She provided an update on digital badges. This is part of last year's HB 1507 which awards students a nationally recognized digital badge upon completion of general education core courses that demonstrate career readiness, beginning with students who initially enter a postsecondary institution in fall 2022. The first digital badge in Effective Communication will be ready in the fall. Students who complete English 1101 will be eligible to earn this badge. Instructions and webinars will be available to help with implementation.

Dr. Falconetti asked Chancellor Hebda to address the proviso language with the funding formula and the potential next steps. Chancellor Hebda said the language goes along with the program fund and includes a proposed equity funding model. The Florida College System Presidents with consultation of the Department of Education will be on a schedule for a recommendation for a funding model by September 2022. She stated that she met with Dr. Falconetti, Dr. Williams, and Dr. Beard to discuss what her office and the budget team have begun reviewing in the proviso language, including the types of data needed to be helpful. Lisa Cook is working on a draft timeline to ensure the recommendations are ready by the deadline.

6.0 Report of the Senior Chancellor– Senior Chancellor Henry Mack
There was no report from the Senior Chancellor.

7.0 COP Committee and Work Group Reports

7.1 Articulation Coordinating Committee

Dr. Sidor reported that the Articulation Coordinating Committee met on February 23, 2022, via Zoom where they approved the October 27, 2021, meeting minutes, the 2021 -2022 Gold Standard Articulation Agreement, and updates for program requirements for the Common Core requisite manual. Most of the updates were around teacher education requested by FTCU. They received updates from the Department of Education staff.

7.2 Florida College System Risk Management Consortium

Dr. John Holdnak stated the Florida College System Risk Management Consortium did not have a report.

7.3 Media and Public Relations Committee

Dr. Tom Leitzel thanked Ms. Karen Moore and Ms. Kendra Moore for their work with the Council of Presidents. He asked Ms. Moore to give the Public Relations update. Ms. Moore shared several media hits and highlighted the in-depth NPR interview with President Falconetti discussing the nursing shortage. The interview was broadcast multiple times on twenty-two stations throughout the state of Florida. She stated the timing of the broadcast was a great advantage to the mission of the COP's goal of resolving the nursing shortage as the interview was broadcast during House and Senate meetings where the nursing shortage was discussed. Over two days the interview had over a hundred media hits. Another positive media hit was the op-ed co-authored by President Falconetti and President Williams in Florida Politics covering the five-point plan to address the nursing shortage. The Moore staff copied and delivered the op-ed to all one hundred-sixty members of the House and Senate. She reported for the second month of the legislative session there were over eight hundred media hits.

She reported during the sixty days of the legislative session the Faces of the Florida College System ran highlighting twenty students from across the State of Florida.

She shared that April is National Community College Month and her team will highlight the twenty-eight colleges in the Florida College System and include a link to each college in the campaign. She encouraged the Presidents to also hold separate media events to highlight their respective colleges.

She stated the final PIO webinar will be held on April 26, 2022, and she asked the Presidents to share the date with their PIOs. During the

webinar, they will present a summary of what happened during the legislative session and discuss what is needed to continue communicating the power, the voice, and the needs of the Florida College System.

8.0 COP Support Council Reports

8.1 Council of Instructional Affairs

Dr. Locklear's written report was included in the meeting materials.

8.2 Council of Student Affairs

Dr. Sidoran's written report was included in the meeting materials.

8.3 Council of Business Affairs

Mr. Bender's written report was included in the meeting materials.

8.4 Florida Council for Resource Development

Ms. Kristen Gammon reported the FCRD conference is April 27 –29. She asked the Presidents to share the dates with their staff and encourage them to register. Both the Spring and Fall conferences will be held virtually. She stated that both the grants and foundation teams are meeting monthly to discuss state and federal outcomes.

8.5 Council for Workforce Education

Dr. Coyne shared that CWE continues to have bi-monthly chats with Senior Chancellor Mack related to workforce development issues. She reported that Senior Chancellor Mack shared updates on the Open Door Grant. He shared the new rule that Open Door Grant participants are not required to file the federal Financial Aid Application (FFAA).

She reported the CWE continues to participate in webinars that provide guidance and address questions and concerns on topics such as the expansion of the Apprenticeship Pre-Apprenticeship Grant, General Education Digital Credential, Florida Student Success Center, Alternative Placement Methods, and the Open Door Grant. She stated they continue to follow the rulemaking related to work-based learning.

She shared they continue to have concerns around HB 7044 which is seeking to have new accrediting bodies after the 5th year of reporting. They will continue to look for support and guidance from the COP on this matter.

She shared other areas of focus and continued discussion for the CWE will center around the curriculum framework innovation/reform, developing program crosswalks including reporting requirements, and a toolkit development for apprenticeship best practices.

Dr. Lorenz asked if the curriculum framework innovation aligns with the promise of curriculum frameworks that will help program approval

be expedited under HB 1507? Dr. Coyne said it would not, however, they spoke to Senior Chancellor Mack on clarification of definitions of the expedited process and why it is called an expedited process. She stated they are all working diligently towards the April 15, 2022, deadline for program inventory submissions, which provides a great opportunity to build out and provide everyone's program to the state to grandfather the submissions into the approval process. Dr. Beard added they have four subgroups that will be answering questions in April, and he asked everyone to submit any questions to him and Senior Chancellor Mack. He will make sure all of the questions are addressed. Chancellor Hebda stated that section 35 has been the hardest part to understand and after the next CRC meeting, it would be a good time to think about how everyone can come together for an understanding of what is involved in section 35. She agreed with Dr. Coyne on the benefits of submitting an inventory of programs and encouraged everyone to complete inventory submissions.

9.0 Florida College System Activities Association

Ms. Kelly Warren stated they did have an approval item for reconferencing alignment for softball and basketball, however without a quorum, they would need to wait until April. She said they are structured similar to the consortium where the FCSAA Presidents' Assembly is the COP. She said the constitution is written so that business can be conducted during the COP meetings. She asked if it would be beneficial to schedule a meeting specifically for the FCSAA Presidents' Assembly to address the reconferencing alignment? If so, she will discuss this with Dr. Avendando when he returns. Dr. Falconetti stated for her to move forward in scheduling this meeting. Ms. Warren provided updates on the national basketball tournaments.

10.0 Association of Florida Colleges Report

Ms. Stephanie L. Campbell gave an update on the Association of Florida Colleges' recent activities, including the AFC Virtual Strategic Visioning Workshop with the St. Petersburg College Collaborative Labs held on February 25, 2022. She reported the workshop provided a great discussion on strategic planning through 2025. Topics discussed were strategic goals for membership, partnerships, collaboration and leadership, Council of Presidents' collaboration, Value Statements, and ROI. She reported the AFC continues to provide Professional Development opportunities for staff at all of the colleges. During March, the ACCESS AFC Professional Development webinar focused on Avoiding Burnout. She shared the upcoming schedule for Region and Commission Spring Conferences and the AFC Virtual Legislative Townhall.

11.0 Announcements/Other Business

Dr. Falconetti asked if there were any announcements or other business from the Presidents. There were none.

2022-2023 Cyber Coinsurance Funding

Beginning 3/1/2022, the cyber liability insurance policy has a \$250,000 deductible for all colleges except MDC has a \$500,000 deductible for all types of cyber claims; in addition, the following colleges have a reduced limit and a 50% coinsurance requirement for **ransomware claims**:

- Chipola College
- Gulf Coast State College
- Miami Dade College
- North Florida College
- ~~Pasco-Hernando State College~~— In compliance, no coinsurance
- Polk State College
- Santa Fe College
- South Florida State College
- St. Johns River State College
- St. Petersburg College
- Seminole State College
- Valencia College Foundation

For ransomware claims, the college would have the \$250,000 or \$500,000 deductible plus a 50% split in the claim adjustment. Please note, several colleges are working to implement the carrier required procedures. Once complete the underwriter will review to remove the coinsurance penalty.

Claim Illustration:

College has a ransomware event totaling \$2,000,000 in loss. Deductible is \$250,000 and the ransomware restriction applies.

1. Ransomware limit \$2,500,000
2. College deductible \$250,000 (As a member of the Consortium, College responsibility is \$10,000; FCSRMC responsibility is \$240,000)
3. Remaining loss \$1,750,000 – this is split 50/50 with the carrier (coinsurance)
4. Carrier pays \$875,000
5. College pays \$875,000 – For a total of \$885,000

FCSRMC recommendation and approval from Operations Committee:

- First year of the coinsurance is funded by FCSRMC
- Second year of coinsurance 50% is funded by FCSRMC
- Third year of coinsurance all college responsibility

Description of Agenda Item:

Summary of concerns regarding SB7044 and request for COP to consider applying to another accreditor as a group.

The passage of SB 7044 requires each FCS institution to switch to a new accreditor following their next 5th or 10th year accreditation. Acceptable accreditors will be determined by the SBOE by September 1, 2022. If *each* accreditor on the list rejects candidacy for an institution, that institution may apply for another accreditor accepted by the USDOE, but not the current one (SACSCOC). If no accreditor accepts the institution before the next accreditation year (either 5th or 10th) then the school may remain with the current accreditor. Concerns include the time and resources needed to apply to (possible) multiple accreditors, the risks of going through a period of candidacy, and the unintended consequences of the law.

CIA would like to suggest that COP:

- 1. Become involved in the process of selecting suitable accreditors that will be on the list approved by the SBOE by September 1, 2022. It is important that accreditors listed be willing to accept applications from Florida institutions.**
- 2. Make themselves aware of the significant financial costs of applying to one or more accreditors. These costs include application fees (up to \$40,000), annual fees, and costs in personnel and time.**

3. Understand the impact to discipline-related accreditation for professional programs.
4. Explore the idea of applying to a different accrediting agency as a group (all FCS institutions). A more cost effective process may be possible if COP negotiates a full-system transfer to another accrediting body.
