Additional Information

Prior to the holiday break, FSCJ petitioned the NJCAA to move to Division 2 in men's and women's basketball beginning Fall 2023. With FSCJ's request, Division 2 basketball is now also impacted.

FSCJ becomes the fourth D2 men's basketball team, joining Florida Gateway, Palm Beach and Pasco-Hernando, making it a FCSAA Championship Sport under current CAA by-laws, which requires four teams to reach championship sport status. While this is a positive move for the teams involved, it represents an additional championship event the FCSAA office is responsible for coordinating. Also serving as a Region 8 Championship event, the winner will advance to a District Championship game for the right to go to the NJCAA Tournament.

FSCJ will be the second D2 women's basketball team, joining Palm Beach. While not a FCSAA Championship Sport, a Region 8 Champion will be determined, and that team will advance to a District Championship game for the right to go to the NJCAA Tournament.

This continued evolution of Division 2 in the FCSAA will result in four additional championship events by March 2024, all of which require a budget to cover expenses such as officials, awards, staff hotels, webcasting, and photography. The D2 volleyball tournament began in 2018 while baseball and softball will host its first D2 FCSAA Championships this spring.

Only the D2 volleyball tournament existed when the FCSAA budget was increased in 2021. Rather than ask for another increase immediately, the recommendation of the FCSAA Executive Director and Associate Director is to charge team entry fees for schools participating in our D2 championships for the 2023-24 and 2024-25 seasons and request an increase to the FCSAA budget in 2025 in advance of the 2025-26 season.

This will provide FCSAA institutions two years to plan for an increase in membership dues while helping provide a startup budget for each of the Division 2 Championships. As an example, entry fees have been part of cross country's championship event since it debuted in 2016. Although entry fees are common practice in the sport, it served the same purpose and has helped take the Championship Event from a starting balance of \$0 to just over \$8,000 in seven years, making the event near self-sufficient.
