## **3.0 2016 Legislative Session**

Dr. Ed Meadows reported legislative staff requested data to justify the \$80 million request for workforce preparation enhancement. Twenty-two colleges have responded so far. The lobbyists have compiled the data, formatted it and sent the format back out to the colleges. The data will continue to be updated as needed.

Mr. Michael Brawer reported there are two bills regarding guns on campus. Mr. Brawer stated he is collecting data regarding the number of dual enrollment students, daycare centers or daycare center training, and charter or collegiate high schools that are on each college campus. He added the cost data is still being collected.

Dr. Ed Meadows reported additional funding for campus safety and mental well-being programs needs to be added to the legislative budget request. He added he will work with the Chancellor in adding it in the request.
