President's Message

Greetings AFC Members



hope you had an enjoyable summer, and perhaps found a couple of days to take some vacation to re-charge your batteries for the school year ahead. The highlight of AFC's summer was the July Membership Development Conference, with a wonderful curriculum developed by the President-elect Juanita Scott and the Membership Development Committee. Attendees learned about new ways to grow chapter membership and to keep members excited about the organization.

Looking ahead, the 2016 legislative

session will begin in January – two months earlier than in most years. In preparation for this early start, bills have already begun filing and committee meetings are just around the corner. Thus, even though we just received our budgets and are still awaiting for the performance funding appropriation, it is time to begin focusing on the next legislative cycle.

Among the first batch of bills are two that would allow for guns to be more carried on campus by persons other than law enforcement officers. As you will recall, one of AFC's biggest legislative victories from the 2015 session was the defeat of these bills. United with partners in law enforcement, the state university system, and national "keep guns off campus" organizations, AFC successfully fought initiatives that would have made our campus more dangerous. The gun lobby does not take defeat easy, however, and this fight will continue another year. As a membership organization, it is only right that

our thousands of different members have different takes on this issue, and on gun rights in general. This is how it should be. As an organization, however, we have taken a stand that the only guns that should be on college campuses are the ones belonging to law enforcement officers.

With this focus on safety, I am excited to announce that a new Commission is in its formative stages – AFC's first new commission in many years! The Campus Safety Commission will provide networking and professional development opportunities for Florida College System employees who are involved with keeping their colleges safe for all students and staff. This might include college police and security officers, mental health counselors, Title IX Coordinators and investigators, student conduct officers, and members of the colleges' Behavioral Intervention Teams. Contact me if you would like information about this new Commission, and you may expect to hear more about them at this fall's AFC Annual Conference.

As we begin the 2015-2016 school year, all members are encouraged to consider what makes AFC such a wonderful organization. When we speak with a united voice as one Florida College System, we speak loudly and with power – this makes us unique in an increasingly fragmented society. The new performance funding model threatens to tear that unity apart, as we begin competing for resources against one another. As we focus on the core values of our Association, we need to stay united and support of the being done by the AFC Legislative Committee, the Council of Presidents, and our Trustees, who will be hard at work advocating for increased funding system-wide and for laws and policies that support student learning and success.

I look forward to seeing you at the AFC Conference in Orlando.

Guns On Campus

Workplace Safety is Equally Important



involved with the pushback on efforts by the Florida Legislature to allow guns to be carried on our campuses by concealed permit holders. This issue is not going away anytime soon and the 2016 Legislative Session portends yet another robust AFC lobbying effort to not pass SB 68 and HB 4001. The Florida College System has the most a stake in this issue. We have 65 campuses and the average age of our students is 29 (the minimum age for concealed carry permits is 21). Thus, we as a system are

likely to have more concealed carriers on our college campuses than a university campus whose average student age is about 22.

The proponents for campus concealed carry repeat a steady mantra of basically two justifications. They cite the Second Amendment rights of all citizens and the idea that a good guy with a gun is the best way to stop a bad guy with a gun. First, this is not a Second Amendment issue. Many people, me included, strongly support the Second Amendment, be they gun owners or not. Like many of our "rights" under the Constitution, however, there are limitations usually implemented to protect the general public. Even communities in Wild, Wild West in the late 19th century determined that it was in the public interest to some degree to limit where guns could be carried in public. We also have the right to

free speech and assembly, but you can't threaten public officials, scream "fire" in a theater, or gather for the intent of starting a riot. We have the right to sue also but not frivolously. Second, I haven't met a law enforcement officer yet who thinks the good guy/bad guy rationale makes sense. The last thing a cop needs is to come upon a crime scene with numerous people pointing guns. And no, they will clearly tell you they cannot tell the good guys from the bad guys very easily and until they control the scene, anyone with a gun in their hand will be treated like a bad guy. And is empowering non-law enforcement people to take the law and policing into their untrained hands a good idea?

In several states campus carry is already legal or allowable to some extent. According to *Keepgunsoffcampus.org*, 10 states have passed gun bills, with varying degrees of limitations. In Utah (2004) it's fully open and allowable. In Oklahoma (2011) it is allowable only in specified areas including parking lots and other areas designated by the college president. Wisconsin (2011) can limit carry by posting signs at every entrance. In Mississippi (2011) an enhanced training is required for campus carry. In Georgia (2012) statutes only allow weapons in a parked vehicle or when picking up/dropping off a student. Arkansas (2013, 2015) allows faculty and staff to carry on campus, unless its governing Board opts out. To date all have opted out but guns are permitted in vehicles in the parking lots. In Kansas (2013), campuses must provide security at every entrance, and if they don't, carry is permitted. Colleges there have four years to comply. North Carolina (2013) allows carry in vehicles in the parking lot. Texas (2013) allows weapons in a vehicle in a parking lot, street, or driveway located on campus. In 2015 they passed a law that

will require four-year institutions to allow open carry by 2016, but a 2/3 vote of the Board can limit locations. In Idaho (2014), an enhanced training is required but dorms and public entertainment facilities with over 1000 seats are exempt. In four states, Oregon, Colorado, Kentucky, and Florida, the courts have overturned long-standing prohibitions that limited concealed carry, and now allow campus carry to some degree, mostly limited to in

vehicles in the parking areas. The University of Colorado must allow concealed carry. In essence, we have quite a bit of precedent across the country for concealed carry on our campuses, and it's going to be a hard battle to oppose it. But we will remain vigilant.

My goal this year is to try to shift the argument to some degree to the workplace safety issue. National data collected by *dispatch*.

com from 15 colleges and universities across Ohio, Michigan, Indiana, Illinois, and Wisconsin found 94% of faculty oppose concealed carry on campus. Moreover, a North Carolina study in the American Journal of Public Health indicates that allowing workers to carry weapons increases the likelihood of an on-the-job site homicide five to seven times. The same study also confirmed that just as North Carolina resident households with guns are more likely to suffer a homicide, so are workplaces. As a former instructor, like many of you, I have been on the end of an irate student's anger over a grade or other matter. Not knowing if a student may be carrying a weapon will place additional stress on college faculty and professional staff, which over time could impact job performance, retention, and potentially the mental health of our employees. Moreover, among students, according to a Ball State University study in 2013, 79% of students reported they would

feel unsafe if faculty, students, and visitors were allowed to carry a weapon on campus. I would wager that our statistics in Florida would be fairly similar.

NBC News reported that workplaces were five times as likely to experience a homicide when they allowed guns compared to those that prohibited all weapons, even after adjusting for other risk factors, according to a 2005 workplace study by the University of North Carolina. According to the Bureau of Labor Statistics, just over

550 people are killed every year, on average, in work-related homicides (which includes guns as well as other weapons). In 2010, more than 10 percent of all workplace fatalities were homicides, 78 percent of which were shootings. That year, the most recent for which the BLS has data, 405 people were shot and killed at work. There are also studies in some of states that allow carry, like Colorado, where the rate of campus rape has increased 25% and 36% (15.2 and 20.8 per 100,000 respectively) in

2012 and 2013. In Utah, the rape rates have fluctuated but increased nearly 50% between 2012-2013.

As an AFC member you can help. Please take the time to contact your local legislators to express your concerns about this issue. Do it in a well-informed and professionally polite manner. The worst thing for me is going in to lobby a legislator and they tell me that they have not heard from anyone in their district who is concerned about this proposed legislation. Go on record and make that contact. Do it from home, not your college office. Do not use your college computer, IPad or phone, or letterhead. Again, be polite, respectful, and professional. If and when you do, please let me know that you did by email for the record.

Be assured, we are working on it and representing our membership on this issue. I will keep you posted via my twitter feed @mbrawer and via the AFC Facebook page during legislative season. Stay tuned.....

he 2015 Membership Development Conference in Jupiter Beach offered attendees strategies to use to enhance membership efforts at their colleges. A workbook planning guide provided a pathway through the key components for membership development. Attendees learned to develop a 30-second elevator speech, determined barriers that affect membership recruitment and retention, identified resources to complement their recruitment efforts, discussed how to utilize social media, and drafted a membership plan to share with chapter and commissions officers to promote AFC.

A chapter presidents panel shared best practices from around the state for chapter awareness and membership development. A review of the AFC values, strategic plan, and overall organizational function was presented. Networking is a vital competent of the AFC and its membership. 



SEMINOLE STATE COLLEGE PRESIDENT DR. E. ANN MCGEE NAMED AMONG ORLANDO MAGAZINE'S "50 MOST POWERFUL"



Seminole State College President Dr. E. Ann McGee was recently named among Orlando Magazine's 12th annual "50 Most Powerful," a list comprising politicians, entrepreneurs, educators, philanthropists and others who are instrumental in shaping the community. She is ranked at #41.

The list, which appears in the magazine's July issue, notes that under McGee, Seminole State has grown from a single campus in Sanford/Lake Mary to a four-campus college offering four-

year degrees to over 30,000 students. Editors noted that the college has a grants portfolio of \$10.6 million, including recent grants for \$900,000 for its sustainable engineering program and \$2 million to provide training for the construction industry. "McGee also has worked with Seminole County Public

Schools to reduce the numbers of incoming freshmen who need remediation in math (from 78 percent to 15 percent)," the profile stated.

As Seminole State's second president, McGee has been at the helm since 1996. She has held academic, administrative and executive positions at Florida Keys Community College and Broward College. She is active in various community organizations, including Heart of Florida United Way, where she is board chairman.

A graduate of St. Petersburg College, McGee is a strong advocate of the value of a community college education. She earned the college's "Most Outstanding Graduate" award in 2009. McGee also holds bachelor's and master's degrees from Florida State University and a Doctor of Education in higher education administration from Nova Southeastern University. She is one of 12 who were on the inaugural list in 2004, according to Orlando Magazine. Among McGee's other recent honors are the Atlantic Institute Central Florida's Global Vision and Education Award in 2014 and the Metro Orlando Economic Development Commission's James B. Greene Economic Development Award in 2013.
