The AFC is the only organization which represents all employees, presidents, and trustees associated with a college system. Today, all 28 of the state's colleges support the work of the Association through institutional dues as do 7,500 members through the sharing of their talents, time and energy.

ACTIVITIES AND EVENTS

During 2017, the AFC hosted and provided support for 30 meetings and conferences serving more than 1,468 members. The AFC office hosts three statewide conferences in addition to four Board of Directors meetings annually. They are the Annual Leadership Conference, the Campus Safety Symposium, and the Annual Meeting and Conference. The AFC provides support to nine Council of Presidents' Meetings and three additional meetings: the Councils of Instructional Affairs, the Council of Student Affairs, and the Occupational Education Standing Committee.

JANUARY

In January, the AFC hosted Legislative Days which provided members an opportunity to visit the Capitol to meet with state legislators. Attendees began the day with a tour of the Florida Supreme Court, toured the Supreme Court Law Library, and visited with Justice Jorge Labarga. Sessions on the AFC Advocacy Process and the do's and don'ts of etiquette and issues messaging were provided. Workshops on how bills become laws and an update on the pending legislative issues were provided.

Later in the week, the AFC Board of Directors met and the Annual Leadership Conference kicked off. At the Leadership Conference, former Lt. Governor Jeff Kottkamp provided insights on his journey to the top of state politics and his start at a Florida College System institution. Attendees also learned about their leadership styles and the importance of leading with a purpose. A panel of AFC officers past and present shared their pathways to leadership and answered questions about their personal journeys. Certified College Professional Program graduates spoke about the program and how completion of the CCP made a difference in their personal and professional lives. Conference attendees were challenged to transform their memberships through recruitment and engagement activities and events throughout the year.

FEBRUARY

The AFC hosted 78 members of the Trustees Commission in Tallahassee for their annual Legislative Conference. The Trustees received information about the 2017 Legislative Budget Request, a prognosis on the legislative session, and discussed the legislative priorities for the Florida College System. At the luncheon, a panel discussion with capitol press corps media provided the Trustees with valuable insight into how the media can assist colleges in disseminating information and telling the FSC story. The following week, the Trustees traveled to Washington, DC to participate in the Association of Community College Trustees National Legislative Summit. A leadership group of Trustees met with Senator Bill Nelson and the staff of Senator Marco Rubio to discuss the reauthorization of the Higher Education Act under Title IV, federal higher educational policies and campus safety issues. Later, Presidents and Trustees met with their respective congressmen from their districts.

APRIL AND MAY

Throughout the spring, professional development opportunities were boundless at the Region and Commission Conferences. Region 2 kicked off the Spring Conferences on April 7th with its theme of "Leading the Way to a Healthy You." Joined by the Facilities, Campus Safety, and Career and Professional Employees Commissions at North Florida Community College, sessions on health and wellness were offered. Stress management, healthy lifestyle practices, and the importance of fitness for overall wellness were a few of the topics. The Facilities Commission held workshops on Hazard Communication and Lockout/Tagout requirements and best practices.

On April 14, the Region 1 Conference, "Not a Spectator Sport Get in the Game" was held at the Tallahassee Community College Ghazvini Center for Healthcare Education. The Equity, Diversity, and Inclusion Commission joined with Region 1 to host the conference. A keynote by Alex Jordan, Director of Student and Administrative Affairs at the Division of Florida Colleges addressed diversity and inclusion. Workshops on creating more entrepreneurial campuses, promoting student success and engagement, sustainability in facilities, and mental health resources for students were also held. Mid-month, Region 3 held its joint conference with the Facilities Commission at Eastern Florida State College. The theme "Leadership Rising: The Future Looks Bright!" was highlighted by a myriad of workshops on leadership including servant leadership, leading volunteers, and transforming lives as a leader. The Facilities Commission held workshops on retrofitting existing facilities, roof preservation, environmental leadership, lockout/ tagout standard, and leading change to reduce fire and safety violations.

On April 28, St. Petersburg College hosted the Region 4 joint conference with the Workforce, Adult, and Continuing Education Commission and the Institutional Effectiveness, Planning, and Professional Development Commission. The theme "Engaging and Empowering Our College Community, One Student at a Time" was highlighted by keynote speaker, Dr. Linda Hogans, the Executive Director of Retention Services at St. Petersburg College. Hogans said supporting students and providing them the necessary resources to stay in college is imperative for student success. Professional development sessions on campus safety, effective teams, collaborative learning environments, meaning conversations, and online faculty training were offered.

In May, the Student Development Commission (SDC) held a spring conference in partnership with the Facilities and Technology Commissions at Pasco-Hernando State College. More than 128 members participated in 12 concurrent professional development sessions and four PechaKucha presentations. Exemplary practice competitions were conducted and SDC Awards winners were announced. SDC celebrated its 50th Anniversary and unveiled a Commemorative SDC Quilt created with conference shirts from past SDC conference. The quilt will be on display in the new AFC Building.

JUNE AND JULY

In June, the second annual Campus Safety Symposium was held at the College Central Florida. Florida State University Chief of Police, David L. Perry, spoke to attendees about the deadly 2014 FSU Strozier Library shooting. Chief Perry shared best practices instrumental in keeping the campus safe during the active shooter incident. Concurrent professional development sessions covering topics such as Title IX and campus security, risk management, crime prevention and facilities management, mental health and college students, and behavioral intervention teams were offered along with continuing education credits. Day two offered a threat assessment training workshop facilitated by Rebecca Bolante, Director of Threat Management Resources at Chemeketa Community College. Sessions included best practice vignettes, core TAT concepts verses BIT, communications and social media, campus workplace issues, and warning behaviors.

The Communications and Marketing Commission held its Conference in mid-July at Florida SouthWestern State College. Attendees went on a historic river cruise and toured the Suncoast Credit Union Arena which is 75,000 square feet and hosts the FSW Buccaneers' basketball and volleyball teams, and a student athletic center. Workshops on Facebook, marketing safety on campus, fake news, increasing enrollments, and a panel discussion with local media were provided. The conference ended with a session on simple steps to relieve stress in the work environment.

NOVEMBER

In November, the AFC came together in Palm Harbor for the Association's flagship event – the Annual Conference – to share best practices, expand networks, and recognize the Association's best and brightest. Held each fall, the Annual Conference is the major opportunity for members and their colleagues to receive professional development and be recognized for their work throughout the year.

The Conference featured an expanded schedule of workshops beginning on Wednesday afternoon and concluded on Friday morning. The Conference provided more than 60 workshops focused on career and professional growth, teaching and learning, student development, technology, and administration and management. Presenters highlighted engagement, innovation, and collaboration. Exemplary practices across disciplines included the Professor of the Year and Best Practices in Communications and Marketing. In-depth training highlighted trends and practical resources available to members. The Annual Service Project brought in items for Hurricane Relief for the Florida Keys.

Keynote Speaker Winston Scott captivated the attendees with recounts of his experiences flying the Space Shuttles. Captain Scott, U.S. Navy Retired, served as a fighter pilot, production test pilot, and as a research and development test and evaluation project pilot flying the F-14 Tomcat, F/A-18 Hornet, and the A-7 Corsair jet aircraft. He shared his leadership philosophy along with life lessons that he learned along the way. The conference culminated on Friday with the announcements of the Chapter of the Year ~ Pensacola State College, Commission of the Year ~ Facilities Commission, and the Region of the Year ~ Region 3.

CERTIFIED COLLEGE PROFESSIONAL PROGRAM

The Certified College Professional (CCP) program is designed to provide a statewide overview of the Florida College System (FCS), enhance individual job performance, build future leaders, and designate college professionals who demonstrate the knowledge essential to the practice of higher education.

With 47% of Florida College System employees reaching retirement age in the next 5-10 years, it is critical that professional development be offered to help bridge the gap and develop the next generation of leaders. Continued improvement and expansion of the program remains a priority of the AFC. With the addition of Instructional Designers to the AFC CCP Committee, we are committed to keeping our core curriculum updated and selecting a world-class learning management system.

Since its inception in 2012, the program has produced 56 graduates, and currently has 56 active participants. The program currently offers four core courses that are available to be taken either in-person in conjunction with major AFC events or online through the CCP portal.

In July, the CCP Legislative Process and Advocacy Workshop was held at Florida SouthWestern State College. Over 30 participants, heard from speakers about the Florida College System, the AFC Advocacy Process, and the Federal Legislative Process. Speakers detailed how bills become laws and how Florida colleges work within the state to move the needle on system issues.

SERVICE PROJECTS

The AFC cares about its community. Community is a core value of the Association of Florida Colleges. Each chapter, throughout the year, participates in numerous service projects giving back to their communities. With 28 chapters statewide, the AFC reached over 60 organizations in 2017.

Additionally, at all of its region and commission meetings and at the annual conference, the AFC selected an organization to recognize and contribute to as it continued to demonstrate its on-going commitment to providing service in Florida's communities. AFC FOUNDATION

The AFC Foundation, Inc. provides charitable and educational financial support to the Association of Florida Colleges, its members and institutions. The AFC Foundation operates three funds.

The Professional Development Scholarship Program annually awards members up to \$300 to participate in any AFC professional development program. Funds may be used for the Certified College Professional Program, the AFC Leadership Conference, the Membership Development Workshop, the Campus Safety Symposium, the Annual Conference, and/or Commission and Region educational events. In 2017, eighteen AFC members received \$3,500 in scholarship funds from the AFC Foundation.

The General Fund provides support for various AFC educational events as well as individual AFC members in need. In September 2017, the AFC Foundation and the AFC each anted up \$10,000 to provide Hurricane Irma Relief Funds to members affected by the devastating storm. \$20,000 was distributed to 68 AFC members from

ADVOCACY

The AFC plays a key role in legislative affairs in conjunction with the Council of Presidents and the AFC Legislative Committee. The committee comprises governmental relations staff from most colleges. It develops a framework for substantive policy and budget issues annually and works strategically to advocate for all 28 Florida colleges. In addition, the AFC is prominent in monitoring and protecting employee issues such as retirement, DROP, tenure and continuing contracts, and campus safety.

Working with contract lobbyists from Ballard Partners Florida colleges fared well during the 2017 Legislative Session. For the third year in a row, the AFC played an integral role in defeating a bill that would have allowed the concealed carry of firearms on our college and across the state who experienced extensive loss to personal property and possessions during Hurricane Irma. Awards ranged from \$100-\$500 depending on need.

The AFC Building Fund has been integral in providing on-going support to the association. Funds are used to help with capital improvements to AFC property. In January 2017, the AFC sold its building at 113 East College Avenue in Tallahassee. That sale netted the association \$1.5 million in cash and left it mortgage free for the first time since 2005. Those funds were then donated to the AFC Foundation which used it to purchase and renovate the new AFC Office Building. The cost of the new property at 1725 Mahan Drive was \$771,000 and required \$400,000 in renovations including installing a three floor elevator system. The new property includes administrative offices for the AFC staff and a large conference room for Council of Presidents meetings and other AFC events.

university campuses. Through the work of our lobbyists, \$83.5 million in PECO funds were appropriated with bonding authority.

Despite our best efforts, a major policy bill, SB 374, was also passed. SB 374 would have overhauled policy for both public colleges and universities and would have created significant statutory changes to the Florida College System (FCS). However, the Governor vetoed the bill. As it stands, the most impactful change from the Legislative Session for the FCS will be a system-wide recurring fund reduction of \$30.2 million attributed to changes in developmental education enrollments. In 2018 the focus will shift to restoring the lost funding and improving student success efforts.

Capitol Perceptions

Capitol Perceptions is published weekly during the annual Florida Legislative Session. This publication provides updates on current legislative issues and bills as they progress throughout the annual session.

Current

The Association's official newsletter, *Current* is published five times each year. *Current* is filled with informative and interesting articles about the community and state college profession as well as AFC activities, members, chapters, commissions and other groups. It is distributed electronically via the AFC website.

Visions

The Journal of Applied Research for the Association of Florida Colleges is published periodically. *Visions* provides a professional forum for the exploration of issues endemic to Florida's community colleges, highlights the research and practices, and provides a proactive voice for the colleges. The Winter 2017 issue was dedicated to a topic that has great relevancy here in Florida and across the nation – campus safety.
